Standard Monitoring

The SPD is monitored with a green indicating light. Contacts for remote monitoring (5 amp, 125VAC)

Connection

GE TLE Series SPDs are equipped with No. 10 AWG copper leads for connection to the electrical system supply. A 30 amp breaker is required as a local disconnect means.

WM4 Model Types




WMF Model Types
